PPE Product

Lite Tech "Xenolite DE" (Lead-free) X-ray protective clothing providing protection to parts of the body with a nominal lead equivalence of 0.50mm at 100kV. This clothing is available in a range of sizes and styles (product codes as follows):

Frontal protection only: 310B, 310S, 310A, 310Q, 310K, 320-NV, 310E, 310R & 310PHP.

Front & back protection: 3201, 3250, 3200TS, 320V, 320S, 330V, 330S, 335V & 335S.

Accessories: 340T (one size only) & 340H.

All of the garments must be worn following the manufacturer's instructions for use to obtain the claimed level of protection.

It is certified that the manufacturer's technical file and the above mentioned PPE have been assessed and found to be in accordance with the requirements of Council Directive 89/686/EEC. When examined the PPE satisfied the relevant requirements in the manufacturer's technical specification¹ (based on IEC 61331-1:1994 test requirements), which had been previously assessed and deemed to meet the basic health and safety requirements (Annex II) of the Directive.

The manufacturer's information notice ("Xenolite" B, NL, TB & DE and "EVAL", Issue # 3) in English has been inspected and found to have addressed all of the relevant requirements of the Directive (Annex II, 1.4).
